



Oklahoma Workers' Compensation Commission (OKWCC)
EDI Claims Announcement – EDI Reporting for Legacy Claims for Release 3.1

Date: August 6, 2018

OKWCC Trading Partners (Direct Reporters) and EDI Vendors testing for mandatory reporting of IAIABC Claims Release 3.1 began on April 9, 2018 and ends August 24, 2018. For purposes of matching a legacy claim in test, the CC-FORM-2 must have been received by OKWCC prior to July 30, 2018. The Mandate Date for OKWCC EDI Claims Release 3.1 is September 1, 2018. The following information outlines 'How OKWCC Legacy Claims were Established' and 'How EDI Reporting Works for Legacy Claims'.

How OKWCC Legacy Claims were Established

- A CC-FORM-2: EMPLOYER'S FIRST NOTICE OF INJURY (CC-FORM-2) that is properly filed with OKWCC by 8/31/18 will create a Legacy Claim. If a CC-FORM-2 is not properly filed with OKWCC by 8/31/18, then a Legacy Claim will not be created for which to match to a FROI or SROI MTC UR. Note: OKWCC does not accept the ACORD 4, OSHA 300 or any other form in place of the CC-FORM-2.
- A CC-FORM-2A: EMPLOYER'S INTENT TO CONTROVERT CLAIM must have been preceded by a CC-FORM-2, and cannot establish a claim on its own in the OKWCC System.
- A CC-FORM-3, CC-FORM-3A and CC-FORM-3B may have been filed with OKWCC; however, if a CC-FORM-2 was not also properly filed, a Legacy Claim would not have been created, and a FROI or SROI MTC UR will not match. If a CC-FORM-2 was never properly filed, then the applicable FROI MTC 00, 04, UI or AU should be sent instead of a FROI MTC UR.
- If you have a CC-FORM 3 Claim Number, it will not be the same as a CC-FORM-2 Claim Number that was assigned when a CC-FORM-2 was accepted. A Jurisdiction Claim Number (JCN DN0005) is not required to be filed on a FROI MTC UR; however, if one is sent, it must be the Claim Number assigned from the CC-FORM-2. If a CC-FORM-3 Claim Number is sent as the JCN on the FROI MTC UR, it will not match the existing Legacy Claim JCN and will reject on JCN DN0005 with error 039 'No Match on Database'.

How EDI Reporting Works for Legacy Claims

- Legacy Claims, CC-FORM-2 properly filed, FROI MTC UR and SROI MTC UR allowed: Per the OKWCC Event Table for FROI MTC UR, OKWCC requires a FROI MTC UR for Legacy Claims for all open and re-opened claims (including indemnity and medical) with Date of Injury (DN0031) >= 2/01/2014 if the claim was properly filed on paper CC-FORM-2. See Event Table for full details. Following the FROI MTC UR, OKWCC will accept a SROI MTC UR (if payments exist for Benefits and/or Other Benefits on the legacy claim) and the SROI MTC UR can then be followed by any SROI MTC that reflects the next action needed on the claim.
- Legacy Claims, CC-FORM-2 not properly filed, applicable FROI MTC 00, 04, UI or AU and SROI MTC UR allowed: OKWCC will publish updates to V1.5 Event Table to add a new FROI Event for MTC 00, 04, UI or AU and SROI Event for MTC UR and revising Sequencing to allow the applicable FROI MTC 00, 04, UI or AU to be reported when the CC-FORM-2 was not properly filed (result is no Legacy Claim is on file). With this change, you will be able to report the applicable FROI MTC 00, 04, UI or AU for all open and re-opened claims (including indemnity and medical) when Date of Injury (DN0031) >= 2/01/2014 for the claims where the CC-FORM-2 was not properly filed. These claims are based on Date Claim Administrator Had (Notice or) Knowledge of the Injury (DN0041) prior to Trading Partner Production Date of 9/1/18. Following the reporting of the applicable accepted FROI MTC 00, 04, UI or AU, OKWCC will accept a SROI MTC UR (payments exist for Benefits and/or Other Benefits). The SROI MTC UR can then be followed by any SROI MTC that reflects the next action needed on the claim. The Sequencing Edit is as follows: SROI MTC UR can follow FROI 00, 04, UI or AU if existing FROI 00, 04, UI or AU (or corresponding 02 or CO) has DN0041 Date Claim Administrator Had Knowledge of Injury < 20180901 (9/1/18 mandate date), otherwise the SROI MTC UR will receive Error 063 Invalid Event Sequence with Element Error Text: *SROIURcannotFollowFROIClmAdmKnow>=9-1-18(S21)*.
